If, in the opinion of CCLRC, the contractor meets the program's standards for qualified contractors, the Contractor's name will be placed on the list of Qualified Contractors, according to trade or specialty. Contractors must be pre-qualified in order to be able to bid for contracted work and contracts will be awarded only to pre-qualified Contractors. CCLRC reserves the right to require additional information. (This form must be filled out in its entirety to be considered as a qualified Contractor.)

Interest of Local Public Officials

The Contractor further covenants that in the performance of this Contract, no person having any such interest shall be employed.

Records and Audits

The Contractor shall maintain accounts and records, including personnel, property and financial records, adequate to identify and account for all costs pertaining to the Contract and such other records as may be deemed necessary by the Government Authority to assure proper accounting for all project funds. These records will be made available for audit purposes to the Government Authority or any authorized representative, and will be retained for three years after the expiration of this Contract unless permission to destroy them is granted by the Government Authority.
